

# Scholarship policy

Academic year 2025 – 26

All scholarships are subject to review and adjustments. Families who are self-employed or have complex financial situations must meet with Rabbi Rosenblum after submitting their application to determine an appropriate scholarship amount since the standard formula does not apply. There are no scholarships for infants, toddler, and twos other than the CCW subsidies. Students on CCW must pay CCW copays and Yeshiva's student fee.

## Scholarship calculation

Scholarships are based on **Adjusted Family Income (AFI)**  
**Adjusted Gross Income (AGI)**

**AFI = AGI + Schedule C/E adjustments + Certain deductions:** Income earned from Yeshiva, daycare expenses paid outside Yeshiva (up to \$5,000), school tuition paid to other institutions up through college (up to \$5,000), and medical expenses above \$8,000 per year. TELC tuition for children in infants, toddlers, and twos.

**Minimum tuition amounts** apply based on AFI and family circumstances

## Tuition percentages

<b>Threes – 8th</b>	13% of AFI	
<b>High School</b>	5% of AFI 17% of AFI	<i>Family also has students in TELC - 8</i> <i>Family does not have students in TELC - 8</i>

## Minimum tuition requirements

<b>Threes / Pre-K</b>	\$4,000 minimum \$5,250 with summer program. Children in PKC will pay a \$1000 minimum for non-PKC hours \$2000 with summer program
<b>Grades K-8</b>	\$3,000 minimum
<b>High School</b>	\$4,000 minimum for girls, \$5,000 for boys

## Staff benefit

**AFI < \$15,000** **No minimum** tuition and **no CCW copays**

**AFI > \$15,000**  
- **50% discount** on TELC-8th grade tuition minimums  
- **20% discount** on aftercare for staff working  
more than 25+ hours a week

## Out-of-town scholarships

Available for families with AGI less than **\$200,000**

Minimum Tuition

- **Greater than 9% of AGI or \$11,500 per student**

- **10% tuition discount** for each

additional out-of-town sibling enrolled

## Self-declared income

Families may self-attest income and **donate the difference** between full tuition and the scholarship-adjusted tuition.

Includes participation in the **Yeshiva SPE program**

## Give or Get

Family contribution expectation

AFI above **\$150,000** or liquid assets over **\$100,000** are expected to **contribute 5% of AFI or liquid assets.**

## Divorced parents

**Apply separately** with tuition responsibilities divided proportionally based on income or court orders.

## Application timeline

Application opens March 6, 2025

Application deadline April 8, 2025

Appeals deadline May 22, 2025

Final appeal decisions July 8, 2025
